**APPROVAL OF MINUTES**

A motion to approve the September 10, 2025 Regular Board Meeting Minutes was made by Commissioner Read, seconded by Commissioner Schott. Upon roll call vote the following Commissioners voted aye: M. Read, S. Stanford, D. Haars, D. Schott and J. Krug. With 5 ayes, 0 nays, the motion carried.

Maintenance has begun winter preparations. Water has been shut off on the grounds; winter equipment is being inspected to ensure all is in good working order.

**Authorize Purchase of a Grasshopper 325D**

A motion to authorize the purchase of a new Grasshopper 325D for the amount of \$15,400 was made by Commissioner Stanford, seconded by Commissioner Schott. Upon roll call vote the following Commissioners voted aye: M. Read, S. Stanford, D. Haars, D. Schott and J. Krug. With 5 ayes, 0 nays, the motion carried.

**Authorize Purchase of a Boss 6'6" VXT Plow**

A motion to authorize the purchase of a Boss 6'6" VXT plow for the Kubota RTV-S100 at a cost not to exceed \$6,600 was made by Commissioner Haars, seconded by Commissioner Read. Upon roll call

vote the following Commissioners voted aye: M. Read, S. Stanford, D. Haars, D. Schott and J. Krug. With 5 ayes, 0 nays, the motion carried.

**Resolution R-141 – Executive Session Minutes – Review for Public View**

A motion was made by Commissioner Read, seconded by Commissioner Stanford to not release for public view the Executive Session minutes listed in Exhibit 1.
