Sixty-seven children participated in the Wacky Water Day event. Mudventures has a huge success. A total of 143 children ran through the course and enjoyed the after-party snacks and drinks.

Upcoming events include Taco Bingo in August, Touch-A-Truck in September and the annual Fall Fest on October 2<sup>nd</sup> with a rain date of October 9<sup>th</sup>. The Godley Ghost Ride will be held on Friday October 29<sup>th</sup>.
